Dear Parents,

Today, the Caesar Rodney School District administration was notified by the Department of Public Health (DPH) that a student at Allen Frear Elementary School and a staff member at our Early Intervention program (EIP) located at Nellie Stokes Elementary School have tested positive for COVID-19.

Through DPH's contact tracing protocol, all families whose students may have had close contact with the individuals who tested positive or who may have been exposed, as well as all staff members who may have been exposed have been contacted. If you did not receive such a notification, it means DPH does not believe your child has been potentially exposed.


The individuals who have tested positive for COVID-19 and anyone who had close contact with the individuals will not return to their respective buildings for at least 14 days.

Primary symptoms of COVID-19 include shortness of breath, coughing, and fever or chills. Other symptoms include congestion, sore throat, diarrhea, abdominal pain, body aches, and loss of taste or smell. Please contact your supervisor if you begin to experience symptoms.

The health, safety, and well-being of our district community remains our top priority. We are following sound protocols aligned with expert health guidance to ensure we are doing everything we can to protect your health. We also want to take this opportunity to remind everyone of the importance of wearing masks, using appropriate safety protocols to mitigate risks, and regularly washing your hands.

We continue to closely monitoring these situations and will provide you with updates if any further steps are necessary.
